Fee Proposal - Feasibility Study Only

Lump Sum, Fixed Fee for Services

Nineteen thousand five hundred dollars, (\$19,500.00)

- Reimbursable expenses are included in the fee.
- The timeline for this scope of work is approximately 2-3 months, based on the District's ability to respond to the work product.

Notes to Compensation:

- The District is a Public entity and is subject to NYS Labor Department wage rate guidelines and the bidding requirements of General Municipal Law Article 101-5A (Wicks Law) requiring a minimum of four separate prime contractors for a construction project. Budgets will reflect these guidelines.
- We will use the NY State Building Code <u>requirement</u> for fire stations as "essential facilities" in our recommendations for the layouts and budgets.
- For this proposal and budgeting purposes, we assume that both sites have soil that is International Code seismic classification of 'C' or better.
- The budgets, layouts and recommendations will comply with applicable provisions of the American Disabilities Act (ADA).
- Billing will be monthly in accordance with the percentage of work completed the prior month.
- The District is tax exempt and will supply a certificate stating this.
- Services for off-site design, hazardous materials removals, environmental studies, traffic studies and other services are not anticipated and therefore not included in our proposal.
- Due to the COVID19 pandemic we can run virtual, or in-person meetings based on the District's preferences.
- This proposal is valid for ninety (90) days.
