CD's – Mr. Simon said the bank is still taking a long time with the collateralization agreements. After the discussion at the last meeting to do four CD's with four different banks rather than finding a bank to collateralize one million dollars, Mr. Passikoff found one bank which could collateralize one million dollars and then the bank switched ownership to a bank with stricter requirements. Mr. Simon suggested moving the money back into the appropriate accounts for the time being and the board agreed that was the right move.

Bond Counsel – Chairman Forschler read the note submitted by Mr. MacLeod stating he could not be here for tonight's meeting. In December, Chairman Forschler will bring a spreadsheet and the commissioners can see the impact of a new firehouse on the budget. Mr. Passikoff should be here for this discussion.

Monthly Calls: Year to Date: 91 **Car 1** Don Estes 5

- There were two calls of interest this month a structure fire in Stanford and a car fire on the Taconic State Parkway.
- The drill last night was a chimney fire review and ladder operations.
- The Forestry grant has been submitted for another floating pump for the new 63. It's a bit larger than the one on 61. The grant pays up to \$1,500 matching for a \$3,000 item. The pump is \$2,990.
- The bumper and headlight are ordered for the new 63. There is no cost estimate as yet. Chief Estes will follow up.

- Update on the new 63 The person putting the emergency lights on had shoulder surgery so it should be going out this week. The radio is in.
- When the new 63 goes into service, the hazmat trailer can be put out to bid.
- Stanford is hosting a trench rescue awareness class in December or January. All members have been encouraged to attend.
- We will do make up modules and two daytime drills in December. Mr. Ruffell Sr. wants to do a fire police training session as well.
- Chairman Forschler told the members at the Monday night meeting that there should be no surprises at the end of this year since the Losap sheets, drills and modules are refreshed and posted each month.
- At the Stanford structure fire, the inch and ¾ line on 12 was utilized and the drain for it took most of the pressure off the knob. This has been rectified and repaired in house. The drain controls are electronic.
- There is a send off for the girls Millbrook volleyball team as they are going to the states on Friday. East Clinton was asked to bring an engine to the parade. It will stay in service.

A motion was made by Chairman Forschler and seconded by Commissioner Tompkins to authorize the East Clinton Fire District bring an engine to the Millbrook parade on Friday, November 17th, which will stay in service.

MCSD Request - The Millbrook Central School District has requested to use this facility to host a community forum. However, this building is not handicapped accessible. The garages cannot be used in the winter as we can't move the trucks outside. Commissioner Shapiro will respond to Cheryl Sprague of MCSD that due to no handicapped accessibility, it would not be appropriate to hold a community forum in this building, adding that the ECFD doesn't even hold their elections in this building. The elections are at the Valley Community Church. Commissioner Shapiro can suggest that she contact the church to see if they can use their facility to host the forum.

Election Inspector Change - A motion was made by Chairman Forschler and seconded by Commissioner Tompkins to give Karen Buechele the authority to appoint either Laura D'Attore or Jesse D'Attore to serve as electoral inspector at the district elections in place of Colleen McGarry.

Election – The election is Tuesday, December 12th at the Valley Community Church from 4:00 p.m. to 9:00 p.m. Thomas Bonanno submitted his completed and notarized nominating form to the secretary. He is the only candidate for commissioner.

Penflex – The board is in receipt of the Service Fee Agreement for 11/1/2023 through 10/31/2024. The base fee is \$4,450, the per participant fee is \$22, and the payment certification and trustee directive letters are \$100 per letter. Fees for the optional preparation of financial statement disclosures are \$595 for the NYS LOSAP Audit Package and \$1,100 for the GASB 73 Package. For Program Year 2022, the board did not have Penflex prepare the LOSAP Audit Package but did have them prepare the GASB 73 Package.

A motion was made by Chairman Forschler and seconded by Commissioner Fierro to authorize Chairman Forschler to sign the standard service fee schedule for the LOSAP plan with an estimated annual cost of \$5,700 plus \$1,100 for the GASB 73 Package.

- Heather Fitzsimmons donated her car to the fire district. The signed title was handed to the secretary who will prepare a receipt on district letterhead for Chairman Forschler to sign. The keys need to be located.
- Joan Tompkins wants to donate her car. The board was in agreement. Chief Estes will call Matt's Auto Body to pick it up.
